If you are under the new teacher evaluation system put in place by DYS or the Deaf or Blind schools: First of all, make sure you read the policy put in place by your agency and follow it. When the agency deviates from policy we need to know about it. Do not be unaware of observations, timelines, and meetings related to your evaluation. Be vigilant to these new changes, and alert your Union leadership if you believe evaluations are not being conducted properly. We wish to work with the state to ensure evaluations are done accurately and fairly.

Site representative elections are coming up in May. Each building with at least 2 members located there should conduct a site rep election. Go to www.aboutscope.oh.us to learn more about elections.

Speaking of elections, remember to register to vote this year, as this election may impact your occupation more than any election in the past. Keep those representatives in mind that have your economic and employment interests at heart, and watch out for the ones that don't.

Lastly, remember to give at least 1 dollar to the OEA Fund for the Children, and if you haven't been asked how to contribute, please contact your site representative for a deduction card. SCOPE's goal is 25% of all members contributing this year. We are currently at 19%.




